It is not possible to prevent against the presence of this disease.

ACKNOWLEDGEMENTS:

My signature below attests that I understand the following:

1. Proof of full vaccination or a negative COVID test will be required for all Conference attendees, including delegates, exhibitors, and speakers. The negative COVID test must be taken within 72 hours prior to attending the conference.
2. I will not attend the NJRPA Conference knowingly having been exposed to anyone who has tested positive with COVID-19 unless I have received a negative test result or have self-isolated for the recommended time frame prior to attending the conference.
3. I will not attend the NJRPA Conference if I am exhibiting any symptoms that are indicative of COVID. I further agree to continuously self-assess and monitor my personal health while attending the NJRPA Conference and notify designated officials should my health change while at the event.
4. I have received and reviewed the NJRPA Health & Safety Conference Protocols and agree to follow them at all times while at the event, including appropriately wearing a mask. I further understand that failure to adhere to those protocols may result in my being asked to leave the conference.
5. The NJRPA Conference Cancellation Policy is as follows: A full refund will be made if a written request is received by January 31, 2022. A 50% refund will be given if a written request is received between February 1 and February 14, 2022. No refunds will be made for cancellations received after February 14, 2022 for any reason.

ASSUMPTION OF RISK: I have read and understand the above statements and warnings concerning the contraction and/or spread of COVID-19. I hereby voluntarily choose to accept and assume any and all risks of contracting COVID-19 and/or spreading COVID-19 for myself in order to attend the NJRPA Annual Conference. I accept sole and personal responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with participation in the NJRPA Annual Conference.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive any right to bring suit against NJRPA and its officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with any claim of exposure, infection, and/or spread of COVID-19 related to attending the NJRPA Annual Conference. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to see damages, whether known or unknown, foreseen, or unforeseen.
