      - **Retail tax-** Retailers, restaurateurs and hotels will be able to immediately deduct from their taxes what they spend on property improvements.
      - **Cruise industry-** No relief.
      - **Telemedicine-** \$200 million for boosting Skype-style health checkups by investing in services and devices that help health care providers connect remotely with patients.
      - **Oil industry-** No relief
      - **Employers and self-employed individuals-** Ability to defer the 6.2 percent tax they pay on wages that is used to fund Social Security.
      - **Insurers-** No relief.
      - **Pentagon-** The Defense Department would field an infusion of \$10.5 billion, including \$1.5 billion for the National Guard to deploy up to 20,000 on-call soldiers to help state response teams fight the coronavirus over the next six months. The bill would also spend \$415 million on research and development work at the Pentagon, aimed at developing vaccines and antiviral medicine.
      - **State and local governments-** 150 billion for state and local governments, with \$8 billion set aside for local governments
      - **Businesses:** Tax credit for keeping idled workers on their payrolls during the coronavirus pandemic, so long as the businesses meet certain criteria. They would get a refund for half of what they spend on wages, up to \$5,000 per worker.
      - **Airlines:** 58 billion. Airlines would receive \$29 billion in grants, and \$29 billion in loans and loan guarantees, as well as a reprieve from paying three of their major excise taxes on the price of a ticket, the fuel tax and a cargo tax. That funding comes with strings, though — no stock buybacks, and limits on executive compensation, to start. Half the funds would go toward “the continuation of payment of employee wages, salaries, and benefits” while the other half would go to loans and loan guarantees for passenger airlines, repair stations and ticket agents — subject to conditions.
      - **Hospitals:** Health care providers would secure \$100 billion in grants to help fight the coronavirus and make up for dollars they have lost by delaying elective surgeries and other procedures to focus on the

outbreak. They would also get a 20 percent bump in Medicare payments for treating patients with the virus.

- **Taxpayers:** All U.S. residents with adjusted gross income up to \$75,000 (\$150,000 for married couples) would get a \$1,200 (\$2,400 for couples) “rebate” payment. They are also eligible for an additional \$500 per child. The payments would start phasing out for earners above those income thresholds and would not go to single filers earning more than \$99,000; head-of-household filers with one child, more than \$146,500; and more than \$198,000 for joint filers with no children

Healthcare facilities (HCFs) should have a low threshold for evaluating symptoms and testing symptomatic HCP, particularly those who fall into the high- and medium-risk categories described in this guidance. HCFs, in consultation with public health authorities, should use clinical judgment as well

as the principles outlined in this guidance to assign risk and determine need for work restrictions.

To help HCFs document and assess HCP risk and exposure, NJDOH has developed the below series of tools and checklists:
